The annual Enrollment/Activity Fee is non-refundable.

Before May 2009 = _____ \$90.00: 2 or 3-Day Sessions / _____ \$100.00: 5-Day Session
After May 2009 = _____ \$100.00: 2 or 3-Day Sessions / _____ \$120.00: 5-Day Session

Fees are due on the 1st day of each month, and past due by the 10th of the month. A late fee of \$10.00 will be charged for overdue/returned payments. There will be a charge of \$10.00 for all returned checks, and you will be required to pay the fee for that month (plus the late fee of \$10.00 & the returned check fee of \$10.00) in cash or money order.

**The tuition is set to cover the operation costs of the school, only,
and does not provide funds for any other program.**

Our policies require us to withdraw any child whose tuition is not paid in full within the month due.

A deposit, equal to one month's tuition is required at the time of student enrollment, in addition to the Enrollment/Activity Fee. This deposit will be used for the May tuition of that school year, or as the last month of attendance if a thirty day (30) written notice is given.

**A late pick-up fee of \$5.00 will be charged for any child picked up
15 minutes after the preschool session ends.**

All children shall be put on a two month trial enrollment to confirm the child's readiness for Preschool. At the end of the two month period the child may be withdrawn at the request of the Director and the May tuition refunded.

Licensing Agency Rights:

The Department of Licensing Agency shall have the authority to interview children, or staff, and to inspect and audit child or facility records without prior consent. The licensee shall make provisions for private interviews with any children or staff member, and for the examination of all records relating to the operation of the child care center. The Department has the authority to observe the physical condition of the child(ren), including conditions that could indicate abuse, neglect, or inappropriate placement.
